This Summary of Terms is not intended to be a substitute of the full Terms and Conditions of Hire and is simply provided to you for ease of reference. In the event of any inconsistency between this Summary of Terms and the full Terms and Conditions then the full Terms and Conditions will prevail.

Rental of Vehicle

We will rent the vehicle and accessories to you ("the Vehicle"), and you agree to take on the rental of the Vehicle, on the terms set out in the full Terms and Conditions and your booking.

Term of Hire and Collection

The term of hire shall be for the period as described in your booking with a minimum of two days. If you wish to cancel the hire within 14 days of the commencement of your hire then you may be charged a cancellation fee of 20%.

We will make the Vehicle available to you at our yard at 90 Buchanans Road, Christchurch or at a secondary location as we may agree with you in advance.

Who may drive Vehicle

You must ensure that the Vehicle is driven only by the hirer or by the persons named on your booking as "Other Drivers".

Each driver must hold a current full driver licence that is appropriate for the Vehicle at all times when they are driving the Vehicle. You consent to us checking the validity and currency of any driver licence used in connection with the rental.

The minimum age of the hirer must be over the age of 21.

Payments

You must pay a deposit of 20% of the cost of the hire at the time that the booking is made.

You must provide a credit or debit card to us and we will place a pre-authorisation charge on that card in the amount of the insurance excess that you selected at the time of your booking. Phat rentals will also deduct any other costs or charges required to be paid by you from your credit card.

The Hire Fee includes 250 kilometres of travel in the Vehicle per day. You will incur an additional fee of 30c for every kilometre travelled in excess of that which will be charged to your credit card.

Insurance

Phat Rentals Limited holds an insurance policy with Vero in respect of the Vehicle ("the Insurance Policy"). A copy of the Insurance Policy is available at the time of booking and will be provided to you at the collection of the Vehicle.

In the event of any accident, damage, loss, or liability whatsoever resulting in you wishing to claim under the Insurance Policy then you must pay the applicable insurance excess.

The insurance excess that is payable by you is determined based on the insurance tier option that you select at the time of booking.

Breakdown

All Vehicles are registered with the Automobile Association (AA) for 24 hour roadside assistance which covers all mechanical and non-mechanical breakdowns.

Accident or Crash

In the situation that the Vehicle is stolen, or you are involved in any accident, crash, or other incident then you must:

- a. Notify Phat Rentals of the full circumstances of any accident or damage to the Vehicle or its accessories as soon as possible after becoming aware of such accident or damage; and
- b. Complete all necessary paperwork (including all insurance documents).

If the Vehicle is stolen or rendered unfit to drive after an accident, crash, or other incident and in our reasonable opinion you are not at fault then Phat Rentals will arrange for repair or a replacement vehicle as soon as practicable.

Return of the Vehicle

You must deliver the Vehicle to 90 Buchanans Road, Christchurch at the time and date specified on your Booking.

Other return locations may be available with the discretion of Phat Rentals and must be agreed in writing prior to the Term of Hire.

You must return the Vehicle in the same clean and tidy condition at the expiry of the Term of Hire as the Vehicle was at the commencement of the Term of Hire. Phat Rentals will inspect the Vehicle at the time of return and will confirm that the Vehicle has been returned in satisfactory condition.
